



## Preschool Registration Agreement 2026-2027

There are 36 weeks of instruction starting 9/3/26-6/10/27 for the 3 year olds and 9/2/26-6/11/27 for the 4 year olds. Students starting in the fall will be billed monthly tuition based on 36 weeks of instruction, the last payment will be in May 2027. Students starting in January 2027 will be billed monthly tuition based on 21 weeks of instruction, monthly tuition through May 2027 plus part of June. Annual Tuition payment discount available for when paid before 9/2/26.

**3 year old program is \$300.00/mo (plus Supply Fee \$150)** Must be 3 by 8/31/26. ACH discount \$280.00/mo.

**4 year old program is \$400.00/mo (plus Supply Fee is \$200)** Must be 4 by 8/31/26. ACH discount \$380/mo.

**Registration Fee:** The Registration Fee is **\$25** (non-refundable).

**Military Discount:** Show Military ID and get the Registration Fee waived. (Must be Active Military and the student's parent.)

**Supply Fee:** \$150 per 3 year old (after 1/1/27 \$115.00)

\$200 per 4 year old (after 1/1/27 \$165.00)

**Registration and Supply Fees must be paid in FULL at the time of Registration to guarantee your child's spot in class. Registration and Supply Fees are NOT refundable at any time or for any reason.**

**Enrollment is for the entire year.** Please refer to the **withdrawal policy** if you plan to leave before June 11, 2027.

**You must pay the full tuition each month, even if your child does not attend class for an extended period.**

**Annual Tuition Discount:** A 5% discount will be given on the Monthly Tuition total only. Registration and Supply Fees not included. Payment due upon registration. Must register by 9/2/26. See front desk for more information.

**Classroom Limits:** Classroom student limits are: 16 students for the 4's and 15 students for the 3's. When you begin, there will be a 2 week probation period. **If we find your child is not a good fit for our program**, we will determine what refund is due, if any, up to a 2 week maximum, and suggest other options that will better suit your child.

**Class performances:** There will be a Winter and Spring performance.

## **Student and Parent Responsibilities:**

**Attendance:** Class is 9am to Noon. Tue/Th for the 3 year old program. Mon/Wed/Fri for the 4 year old program.

**Your child must be a fully independent potty user.**

**Snacks:** The parents are required to send a healthy snack from home.

**Late Pickup:** Parents must be ready to pick up their child as soon as class is adjourned. A \$2.00 per minute fee will be charged for late pickup to be paid with the next month's tuition payment. Charges for May/June will be charged on or about June 14, 2027. (5 minute grace period before late pickup charge.)

**Withdrawals:** Please inform the office and the teacher if you decide to withdraw from the program before June 11, 2027. Two week's notice is required for any withdrawals. If you withdraw from class no matter when/why, the current month's tuition must be paid in full and is not refundable. **Remember there are no refunds on the Registration and Supply Fees or current month's tuition.** *If you withdraw after August 19, 2026 , or if you do not show up for class(es) when they begin on September 2 or 3, 2026 you are responsible for the full September Tuition—to be charged to your preferred payment method on or about September 1, 2026.*

**Holidays:** The preschool will follow District 81 "holiday" schedule for school closures.

The studio/preschool will be closed if District 81 cancels due to snow or in the event of an unforeseen natural disaster. In the case of a 2 hour school delay, preschool will be held at the Director's discretion, notification will be made via text message by 7:30 am. If these closures occur, there are no refunds or make-ups. The Director has the right to override District 81 in the case of extended closure.

**Vacations/extended absences:** If your child will miss more than 2 classes due to a vacation or other event, contact the preschool teaching staff. Monthly Tuition must be paid in FULL with extended absences, no matter the reason.

**Liability/Indemnity Agreement:** I/we agree to hold harmless the Dance Center of Spokane/Creative Minds Bright Minds Preschool, its Employees and its Lesser from any and all liability claims, actions judgements, damages and injuries of any kind and nature whatsoever to the participant and/or his/her/ property arising from participation in activities for which the participant is registered. I/we have familiarized ourselves with the description of the activities and understand the hazards, the participant's personal limitations and knowingly assume all risks. Illness: I agree to keep my child home if they have a fever of 100.4 or higher in the past 24 hours or show signs of illness including vomiting or diarrhea in the last 24 hours. You can return to class after at least 24 hours have passed without the use of fever reducing medication AND a minimum of 24 hours of recovery from symptoms.

**Billing Agreement:** Tuition is due on the 1st of each month September 2026-May 2027, including June 2027 if you start after 1/1/2027. Tuition is \$300/month for the 3's and \$400/month for the 4's. If you choose to pay via ACH, your tuition rate will be reduced by \$20/month to \$280/month for the 3's and \$380/month for the 4's. See Payment Agreement Form to make your payment choice. I understand the Registration and Supply Fees are non-refundable and I am responsible for the full September Tuition if I withdraw my child after August 19, 2026, or if my child does not show up for class(es) in September. A 3% surcharge will be added if a credit/debit card is used to pay the Registration and Supply Fees or other fees. A Late Fee of \$15 will be applied for any debt 30 days past due. An additional late fee will be charged every 30 days any debt remains outstanding. A \$10 payment decline fee to be assessed each time any payment declines.

I have read and understand the above preschool registration policies.

\_\_\_\_\_ My child started Preschool before 12/1/2026. This option is based on 36 weeks of instruction.

\_\_\_\_\_ My child started Preschool after 1/1/2027. This option is based on 21 weeks of instruction. The last payment will be 1/4 payment in June.
